ET'S be honest about it: Fantasia was not presented with a difficult task in last week's Nell Gwyn Stakes. If she had failed to win, we would have lost all faith in the form book.

But wow! She didn't just win. It's not often that we see a Classic trial won in quite such devastating style.

Held up in rear under a confident Dettori ride, the filly came through her field effortlessly to lead over a furlong from home, and a shake of the reins later she was out on her own, leaving her pointless pursuers further and further behind. The eventual seven-length margin over Damaniyat Girl did not begin to express the degree of her superiority.

In a normal year that performance would have ensured that Fantasia returned to the Rowley Mile on the first Sunday in May, at least vying for favouritism for the 1,000 Guineas. But once George Strawbridge had opened his cheque book to add the daughter of Sadler's Wells to his collection, this became something other than a normal year.

The Pennsylvania-based owner has last year's juvenile champion filly, his home-bred Rainbow View, as his preferred candidate for the Newmarket Classic, so he has understandably decided to divert Fantasia to Longchamp for the Poule d'Essai des Pouliches a week later.

Rainbow View, still unbeaten and seemingly in good heart when she had her public gallop before racing last Thursday, inflicted Fantasia's only defeat to date when they finished 1-2 in the Fillies' Mile at Ascot last September. Fantasia had previously performed above expectations to score on her debut over 6f on Newmarket's July course, then won the Group 3 Prestige Stakes (7f) by a length over Rose Diamond, while suggesting that she had rather more to spare.

There was no excuse for Fantasia when Rainbow View claimed the Ascot prize and the championship that it conferred; she was beaten fair and square – by $2^{1/2}$ lengths – on the day. For all that, many formed the impression that as three-year-olds their relative merits might be different, with the small, highly strung Dynaformer filly seeming less likely to progress than her scopey, sober victim.

There is no doubt that Fantasia has progressed over the winter. She attained a new level of form in the Nell Gwyn despite a modest early pace and an inadequate trip, and she looks the type to continue thriving as the season develops.

What we do not know yet, and only time will tell, is the limit of her stamina. She has been quoted at short odds for the Oaks - perhaps for no better reason than it would seem folly to offer her at long odds – but punters would seem well advised to wait for further evidence before jumping in. Her pedigree conveys conflicting messages.

Fantasia comes from the 21st crop by the now-retired Sadler's Wells, whose 14-year reign as champion sire ended in 2004, but whose influence has by no means abated.

Last year he was the sire of the champion sire (Galileo), he has led the broodmare sires' table in each of the last four completed seasons, and he continues to make an impact with his own racing progeny; the Nell Gwyn provided Pattern victory number 309 in his unparalleled career.

Because there is such an enormous body of evidence about the sons and daughters of Sadler's Wells on the racecourse, it might seem that it should be possible to predict what lies ahead for Fantasia in terms of her staying capacity.


But we must never forget that every horse is a unique individual, with its own complement of genes, and even in the case of a prepotent sire whose stock are all bay with splashes of white about them, there can be – and frequently are – marked differences in what they are able to accomplish as athletes.

We can generalise, asserting that the typical Sadler's Wells product is not precocious, rarely making an impact before the latter half of its first season, it tends to be better at three, especially beyond 1m, and if it's allowed to race past the age of three, it might be expected to improve again. In addition, some give in the ground seems to suit.

There are any number of Sadler's Wellses who conform to that pattern, but all too many exceptions for such a generalisation to be acceptable as a hard and fast rule.

He has had his share who produced their best form at two, he has had runners who did not improve for venturing past 1m, and in 2007 he was represented by a total aberration in Liscanna, his one and only winner of a Pattern race sprint, other than a juvenile.

Yes, Sadler's Wells was prepotent, but that doesn't mean that his mates had no influence on their offspring.



Sadler's Wells on mares by Darshaan, of which Fantasia is an example, has been tried on numerous occasions, and we might be tempted

to draw some conclusions from previous results. Among them we may cite Ebadiyla, who won the Irish Oaks and Prix

Royal-Oak, Milan, successful in the St Leger, High Chaparral, winner of two Derbys and two editions of the Breeders' Cup Turf, Islington, twice a winner of the Yorkshire Oaks, and Septimus, who ran away with last year's Irish St Leger.

If those examples read like a recommendation to lump on Fantasia for the Oaks, think again. The fact that she has elements in her background in common with those superior stayers does not make her a certainty to follow suit.

Her genetic make-up is her own, unique to her, and, for all we know, very different in terms of stamina endowment.

We do not need to look much further back into Fantasia's pedigree to understand why she may be different. Her grand-dam, by Danzig, won the Queen Mary and the Cheveley Park Stakes. And she was out of a daughter of Habitat who won the Prix Maurice de Gheest.

Those influences may just have been a factor in Fantasia's debut victory over 6f in July, when punters let her go off at 8-1, assuming that a daughter of Sadler's Wells out of a Darshaan mare would want more time and distance

Later evidence from Fantasia herself has provided proof that she gets 1m and a strong hint that 1m2f will be within her compass.

The Oaks is by no means out of the question, but those Danzig and Habitat factors just might come into play to inhibit her.
